- A. WHEREAS the aforesaid SETTLER has been desirous of creating and establishing a Minority Charitable Trust wholly for philanthropic and charitable purposes under the name and style of "SAINT ARNOLD EDUCATIONAL TRUST" with its principal place of operation situated in MYSORE, KARNATAKA STATE, INDIA, hereinafter referred to as the TRUST by declaring a certain sum of money as Trust property and settling it in Trust on the PARTIES of the SECOND PART INCLUDING HIMSELF for carrying out certain public charitable objects and purposes more fully described in this Deed of Declaration of Trust which are wide enough for the extension of the benefits thereof to all mankind, in respect of education and advancement of any object of general and/or public utility and so that such benefits may be given directly by the said Trust to such needy and deserving persons and appointing the TRUSTEES herein as the TRUSTEES of the Trust property to carry out the objects and purposes of the Trust and to exercise certain powers and rights as set out in detail hereinafter;
- B. WHEREAS the SETTLER being, inter alia absolutely seized and possessed of the sum of Rs.1,000/- (Rupees One Thousand only) set apart by him for public charitable purposes hereinafter mentioned, was desirous of settling the said sum of Rs.1,000/- (Rupees One Thousand Only) by cash as the Corpus Fund earlier today, subject to the powers and provisions hereinafter confirmed, declared and contained of and concerning the same in the manner hereinafter appearing.
- C. WHEREAS the SETTLER has reposed immense confidence in the TRUSTEES by virtue of their standing in the society and the experience they have gained in their business and other professions, of the SECOND PART as well as in himself to achieve the objects and the purposes of the Trust and to exercise certain powers and rights in relation thereto and has pursuantly requested the aforesaid PARTIES to accept the said cash of Rs.1,000/- and herein to act and they, in fact, have acted as the FIRST TRUSTEES of the Trust on and from this day of 6<sup>th</sup> FEBRUARY 2006.
- D. WHEREAS accordingly the FIRST TRUSTEES have assumed office as TRUSTEES OF "SAINT ARNOLD EDUCATIONAL TRUST" and have agreed to commence the public charitable activities at MYSORE CITY, MYSORE TALUK & DISTRICT on and from the 6<sup>th</sup> FEBRUARY 2006.
- E. WHEREAS the SETTLER and the TRUSTEES herein are now desirous of confirming their oral Trust into writing and to reduce the constitution of the said Trust, objects and other rules and regulations as decided by the SETTLER and as accepted by the TRUSTEES at the time of the oral formation of the Trust into writing and to have the same evidenced and confirmed by this DEED of confirmation of Public Charitable Trust.



**NOW THIS INDENTURE OF TRUST WITNESSTH AS FOLLOWS:**

01. In order to effectuate and evidence the aforesaid object of creating and establishing a Public Charitable Trust the SETTLER herein confirms having delivered to and made over to the TRUSTEES of the SECOND PART, a sum of Rs. 1,000/- (Rupees One Thousand Only), by cash with intent to part with all his rights, title interest and claims therein and vest the same in the TRUSTEES to have and to hold the same and the investment(s) for the time being representing the same and all other properties that may for the time being represent the Trust estate together with all additions and accretions thereto and all accumulated income thereof and all other property or properties that may be acquired out of the same or otherwise may hereafter be subject to the Trust (hereinafter referred to as "THE TRUST FUND") for the public charitable objects and purposes and uses hereinafter expressed with the powers and on the terms and conditions herein contained of concerning the same.

**02. AIMS AND OBJECTIVES OF THE TRUST:**



The aims and objectives of the Trust shall be as hereunder:


- A. (i) To create, organise and run colleges, schools, institutes, Teacher Training Institute, Polytechnics and other centres of learning and with the counter-parts like Kindergartens, Hostels, Gymnasias, and Libraries. (ii) To construct, equip and maintain these Institutions and to create the means of raising revenues for Trust. (iii) To strive for maintenance, growth and development of academic standards and to enter into collaboration agreement etc. (iv) To help the poor and organize charities for needy students.
- B. To promote, establish, carry on, set-up, run, administer, maintain, assist, finance, support and/or aid or help in the setting up of training centres to provide employment opportunities to the unemployed and needy. The Trust is also empowered to construct buildings, roads, community halls, library, reading rooms, museum, guest houses, swimming pools, parks, play grounds etc. for the benefit of the general public.
- C. To promote, organise, administer, support, maintain and/or grant aid to any person, individual, institution, society or organisation of a public charitable nature and carry on activities in imparting education in any areas as well as assisting such institutions already in existence, including awarding scholarships to the poor and needy students.







- E. To print, publish and exhibit films, CDs, Cassettes, journals, periodicals, books, lectures and other reading and pictorial matter for the diffusion of useful knowledge and in keeping with the objectives of the TRUST.
- F. To set-up, build and/or maintain infrastructural facilities for the implementation of any or more of the above charitable programs or purposes or activities.
- G. To buy, acquire, invest, dispose of, sell, transfer, lease or acquire on lease or licence or otherwise deal with the subject matter, properties and/or assets of the Trust in such manner as the Trustees should deem fit so as to enable them to carry out the objects of the Trust.
- H. To accept donations, grants, presents and other offerings from person(s), institution(s) or organisation(s) in India and abroad, subject however to the restrictions and regulations of the laws of the land and to deal with the same for the purposes of the Trust.
- I. To hold and conduct classes, lectures, conferences, seminars and competitions and to give scholarships, free-ships, diplomas, certificates and awards as and when though fit in the attainment of the objects of the Trust.
- J. To do, execute and perform all such acts, deeds and things as are incidental or conducive to the attainment of the above objects or any of them.

03. PARTICULARS OF NAME, OFFICE ETC.:

The name of the Trust shall be "SAINT ARNOLD EDUCATIONAL TRUST" and the registered office of the Trust shall be situated at VIDYA NIKETAN, SITE NO. 80, BANNIMANTAP, 'B' LAYOUT, MYSORE 570015. The registered office may be shifted from time to time to such other place(s) as the TRUSTEES may deem fit and proper at their discretion.



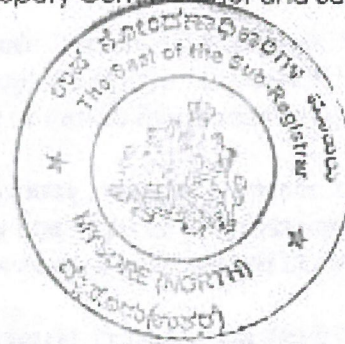
